- If balance of user will be lower of deposit amount, then profit value won't calculate and withdraw won't work.
- Deposited amount is rebalanced with current deposited amount to current balance rate.

Owner privileges (In the period when the owner is not renounced)

- Owner can change apr address.
- Owner can change fee amount.
- Owner can change fee address.
- Owner can change feePrecision.
- EarnAPRWithPool owner can add fulcrum, fortube, venus and alpaca token addresses.
- APRWithPoolOracle can change alpaca token index.
